

## **ANNOUNCEMENT FOR THE SELECTION OF RESIDENT CHAMBER GROUPS FOR THE VIII GRAMADO IN CONCERT**

The organization of the VIII GramadoIn Concert makes public the present Announcement that regulates the selection of Resident Chamber Groups.

### **1. ABOUT THE OBJECT**

1.1 The object of the present announcement is the selection of Chamber Groups which will participate as Residents of the VIII Gramado in Concert - International Music Festival, which will take place between February 12th and 19th 2022 in the city of Gramado-RS. Full scholarships will be offered to three chamber groups with a total of fifteen (15) members.

1.2 The purpose of this announcement is to encourage the promotion and qualification of Brazilian and international Chamber Groups.

### **2. ABOUT THE CONDITIONS**

2.1 Brazilian and foreign chamber groups with from 3 (three) to 6 (six) members can register.

2.2 The minimum age for participants must be 18, there is no maximum age.

2.3 The group's instrumentation must be compatible with the workshops offered in the event, that is, it may include the following instruments: violin, viola, cello, double bass, oboe, flute, bassoon, clarinet, saxophone, trumpet, French horn, trombone, euphonium, tuba, and percussion (instruments common to symphonic practices).

2.4 Only applications from chamber groups that have been in existence for 6 (six) months or more will be accepted.

2.5 The groups should arrive in Gramado on the 11th and leave on February 20, 2022.

### **3. ABOUT THE SELECTED GROUPS' ACTIONS**

3.1 Each of the three (3) selected groups will perform three (3) exclusive recitals of 45 to 60 minutes and one (1) recital shared with the other chamber groups, where each group will perform for up to 20 minutes. The recitals will be in places and at times chosen by the event's organization and will be part of the Artistic Program of the Event to be held between February 12 and 19, 2022.

3.2 The members must participate in the Group Practices for which they are selected by the Festival's Artistic Direction and will have the right to participate in the workshops of their instrument.

3.3 Those selected must use their own instruments and music stands during the festival, the event will make available only piano (electronic keyboard) and percussion (according to the event's availability).

#### **4. ABOUT FESTIVAL'S CONTRIBUTION**

4.1 The members of the 3 (three) selected Chamber Groups will be considered Full Scholarship Students and thus will be exempt from the registration fee, will receive accommodation (students' hotel) and food (breakfast, lunch and dinner) for up to 09 (nine) days.

4.2 Besides participating in the event's Workshops and Group Practices, they will have Chamber Music Coaches with the event's teachers.

#### **4. ABOUT REGISTRATION**

4.1 Registration will open on December 27, 2021 and will remain open until January 4, 2022.

4.2 To register, simply access and fill out the Registration Form available on the event's website.

4.3 In addition to filling out the required information, the group must include in its Registration Form, a video link, hosted on the web, showing an excerpt from a public presentation of the group.

4.4 The announcement of the selected groups will be made within 03 (three) days after the end of registration. Members of the groups that are interested in participating in the event, even without being approved in this announcement, should register as a student in addition to the group registration, because in this way, if the group is not selected in this announcement, they can make the payment as the other students.

#### **5. ABOUT THE EVALUATION**

5.1 The Evaluation Committee will be formed by members of the Artistic Direction of the VIII Gramado in Concert.

5.2 For evaluation will be considered the fulfillment of the requirements of the Registration Form, history of the group, relationship with the nature of the event and artistic quality of the group.

#### **6. ABOUT THE USE OF PHOTOS, AUDIO AND VIDEO RECORDINGS:**

The participation in the VIII Gramado in Concert implies the free assignment to the Festival organization of all your voice, sound and image rights, which may be captured by the Festival or third parties on its behalf, for inclusion in any type of material support existing today or in the future, being the Festival free to dispose of them, as well as their extracts, excerpts or parts, giving it any use, for example, adapt it for purposes of production of audiovisual works, for exhibition through screen projection in collective homes or public places, with or without paid ticket, broadcast by radio and/or television of any kind (open television or pay television, by all existing forms of signal transport, such as UHF, VHF, cable, MMDS and satellite), adapt it to any format, broadcast advertising, as well as fix it on any type of material support, such as cinematographic films of any gauge, CD, CD-ROM, CD-I (Compact Disc Interactive), home video, DAT (Digital Audiotape) DVD (Digital Video Disc) and computer graphics supports in general, store it in a database, disseminate it

through the internet, via cell phone, including downloads, WAP, SMS assign the copyrights on the work produced to third parties for any kind of use (unpaid), use excerpts or extracts thereof.

The Chamber Group, through its registration, authorizes the use of its name and members in artistic performances, images and voice, as well as assigning, free of charge, the copyrights on the works sent, allowing the use of these, without any limitation of time, eg, but not limited to photos, posters, films, spots, in any media used by the Festival organization for its marketing campaigns, including but not limited to television media, newspapers, magazines, billboards and/or digital transmission media, with or without a provider, including assigning these rights to third parties.

## **7. ADDITIONAL INFORMATION**

7.1 The act of registration implies full acceptance of the rules contained in this Announcement.

7.2 The travel from the city of origin of the group to the place of the event, as well as the return, will be under the responsibility of its own members. The event does not offer to the selected Chamber Groups, air tickets or any other type of transportation for the arrival to the event and return to the place of origin.

7.3 In case of desistance, the selected group must inform the event at least 30 days before the beginning of the event. In this case the coordination may call chamber groups on the ranking list to replace them.

7.4 The Gramado in Concert Organization will decide on any cases not covered by this Announcement.
